### Program Highlights

#### Transitioning from the Configuration and Prototyping Phase to the Testing Phase

Finalizing the design of our consortium’s Workday solution is a huge milestone for the program, marking the end of our Configuration and Prototyping Phase, and allowing us to officially transition to the Testing Phase. The team is currently working on building our new Workday tenant, which will be used for upcoming testing activities. The new Tenant will include our latest Financials (FIN) and Human Capital Management (HCM) configuration as well as each institution’s converted data. The data conversion effort is a significant undertaking where each institution’s Peoplesoft data is extracted and then loaded into the Workday Tenant. This effort will be repeated several times during the program implementation timeline and give us greater assurances that our data can be trusted as we march towards cutover and go-live next year. In June, our team will start our first End-to-End (E2E) testing cycle. E2E testing is a way to make sure that our designed Workday system behaves as expected and that the data accurately flows across all user tasks, processes, and external systems. This type of testing starts from the end user's perspective and simulates real-world scenarios.
