

Letter of Financial Support for F1 Visa Applicants

This document must be completed, signed, and submitted via the application portal before an admitted student may be issued a Form I-20. It should be accompanied by financial documents less than six (6) months old at the time of applying.

DECLARATION OF FINANCES FOR INTERNATIONAL STUDENTS

You must demonstrate a minimum balance of \$30,000 (or its equivalent in foreign currency) in traditional checking or savings account to cover your first year of tuition expenses and incidentals. Financial support can come from multiple sponsors as long as it adds up to \$30,000 in total. Brokerage, stock or equities funds, income letters, pay stubs/statements, real estate funds and/or any non-liquid assets may not be included.

Fill out the statement from the second sponsor (on the next page) only if there is a second sponsor.

If you are bringing immediate family members (spouse or children), you are required to show an additional \$3,000 per dependent.
